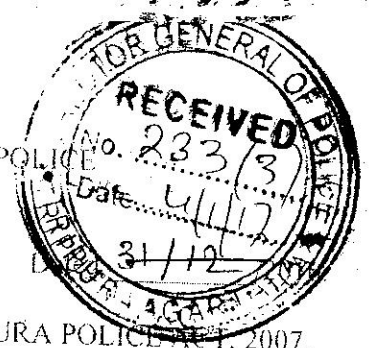

GENERAL NOTICE UNDER SECTION.81(2) OF THE TRIPURA POLICE ACT, 2007,
(ACT 6 OF 2007).

WHEREAS, I, Abhijit Saptarshi, IPS, Superintendent of Police, West Tripura District, Agartala I am satisfied that, it is intended by persons or organizations to organize assembly, procession and other programme using loud speakers and other sound systems in public places, in the West Tripura District,

AND

Whereas, such assembly, procession and other programme is likely to cause breach of the peace obstruction, annoyance to passer by or pollution in the area, if such procession, assembly or programme is allowed without due control and regulation.

Now therefore, in exercise of the power conferred upon me under Sub-Section (2) of section 81 of the Tripura Police Act, (Act-6 of 2007), I do here by prohibit all such activities for keeping order on public roads, streets, thoroughfare or any public place in West Tripura District, in order to prevent breach of the peace, obstruction, annoyance to passers by or pollution. If any person or organization intends to organize any such programme, necessary prayer has to be submitted to this office at least 48 hours before commencement of the programme notifying date, time, place, route of movement and expected number of participants.

This order shall come into force within the jurisdiction of ENTIRE WEST TRIPURA DISTRICT, with immediate effect. Any person violating the above order will make him liable for prosecution under the provisions of Tripura Police Act, 2007. (Act 6 of 2007).

This order remains in force up to 30-06-2017.


