**NOW, THEREFORE**, in exercise of power conferred upon me under Rule 105 of the Tripura Motor Vehicle Rules, 1991 read with Section 116 & 117 of Motor Vehicles Act, 1988, I do hereby specify the 'No Parking Zones/Free Parking Zones'.
